Interest rates and APY (annual percentage yield) depend upon the applicable rate tier. Savings Account interest is variable. Interest is compounded and added to the account quarterly. The daily balance method is used to calculate Money Market Account and Savings Account interest. Variable interest rates may change after the account is opened. Account fees could reduce earnings on NOW Checking and Savings. Minimum balance is the minimum required to obtain the stated APY. The APY is accurate for the stated time period.
